Local Plan – Consultation on Proposed Main Modification in respect of Local Green Space at Udney Park Playing Fields, Teddington

Following an application to the High Court for a statutory review (under s.113 of the Planning and Compulsory Purchase Act 2004) in respect of the adoption of the Richmond Local Plan (on 3 July 2018), a <u>Court Order</u> has quashed paragraph 5.2.8 in the Local Plan, which relates to the designation of land as Local Green Space LGS).

The Court Order requires the Council to publish the Inspector's proposed change to paragraph 5.2.8 in the <u>Publication Local Plan</u>, together with an explanation of its effect in terms of it representing the proposed removal of the Local Green Space designation from Udney Park Playing Fields, as a proposed Main Modification to the submitted version of the Local Plan for public consultation, for a period of six weeks. This is set out in the following schedule.

An <u>Addendum</u> to the <u>Sustainability Appraisal of the Publication Local Plan</u> in respect of the proposed Main Modification has been published.

This consultation is <u>only</u> on this proposed Main Modification in respect of the Udney Park Playing Fields and not on other aspects of the Plan. It does not provide the opportunity to raise any other potential sites in the borough for designation as Local Green Space or any other matters. Main Modifications are those which the Inspector considers are necessary to make the plan sound and/or legally compliant. Main Modifications are proposed without prejudice to an Inspector's final conclusion on this issue, which will take account of all representations submitted in response to this consultation.
