Agenda Item One: Police update/short Q and A

Headline Topic: Fatal Stabbing in Craneford Way 12 th Oct 2021	
Councillor Ehmann	Recent fatal stabbing on Craneford Way needed to be addressed in this meeting as it impacts directly
	on St Margarets and North Twickenham/Twickenham Riverside Ward residents. The Neighbourhood
	Inspector Jon McGloulin has joined us tonight and is engaged closely with the Council. Firstly

	condolences to the family of the victim of the stabbing. To emphacise though at this time there is limited amount that both the Council and Police can say as it is an ongoing investigation. Inspector Jon McGlouglin: give the condelences of the Police. It is a tragic circumstance, but also a rare occurrence. Police wish to offer reassurance to residents and there will be an increased presence of Police Officer in Craneford Way and the crime scene will remain cordoned off for the next 24-48 hours. I cannot comment on the investigation at this stage. MP Munira Wilson and the Council are working closely with Richmond Upon Thames College and as a member of the public do feel free to speak to the Officers on the beat with any concerns or information you may have. The Police Schools Liaison Team are also working with local schools, especially those who witnessed the events from the Craneford Playing Fields.
Cllr Ehmann	The Police has committed a visible presence in Twickenham beyond the investigation area.
Steve O'Shea	There has been some discussion around the victim being an Afghan national. How can we offer support and integration and safety for foreign nationals Insp. McGlouglin: We cannot say at this point as we must follow the Press lines to limit the release of information whilst the crime is under investigation. I can comment that the Police are offering reassurance and safeguarding measures for local people.
Hamish	Will there be a face to face meeting to reassure the public and discuss how to reduce risk in the College area. Clir Ehmann and Insp. Mc Gloughlin: Happy to cooperate to make this happen.
Karen Trueman	Noticed a drop in Police presence during Covid 19 lockdown and an increase in crime. Will there be an increased presence of Police now? Insp. McGlouglin: Insulate Britain/Vaccine protests and other central London demands have often taken Police out of the local area. In the short term there will be a greater presence and my aim is to make the ward teams work closer together to cover the area more effectively.
Michael Jay	Not helpful to have reassurance after the event. The lack of Police has led to an increase in Kinfe culture. Insp. McGlouglin: There is a need for more Police, but there is also the need to recognise this is a rare occurrence. But there is a need for the Police to be seen as a deterrent to crime.

Want to overturn decision with SWR • Changes to St Margaret's Station improvements, prior to Covid step free access via Amyand Park Road finally and pedestrian footbridge fully refurbished to high standard and graffiti removed. • Investment in Moormead and Grimwood playgrounds – overhauled and new equipment especially Grimwood. Positive improvement • Launch consultation on Railshead Rd in North St Margaret's joins Twickenham Riverside pathway, hostile space for walkers and pedestrians due to narrow pavements, often parked on ... Shared space environment in future in consultation. Financial uplift to road • Ward councillors pressed for improvements on A316 corridor for cycling and pedestrians, under TFL control but had no firm commitments from TFL, although Council has had a consultant design improvement for segregated cycling/pedestrian ways and written to TFL with an offer of partial Council funding to support a TFL run 'A' road. • The Moormead Pavilion dilapidated, currently fenced off. An application is with planning department from Moor mead FC grouping, construction of new pavilion supported by ward councillors, but objection from Sport England which has now been withdrawn due to Council Officers and Moormead FC intervention. Support of ward councillors at planning committee. Keen to see progress on this site.

High Street Rejuvenation Paul Clement: The development of High Streets has had its ups and downs, but current changes are unique due to the Covid 19 pandemic. The pandemic has had a devastating impact on business and sped up the evolution of the High St. In the last 18 months there has been an opening up of the local neighbourhood and reconnection with the values of local community. People have been travelling less and appreciating their local services. People's lifestyles have changed with hybrid working and thereby spending more time in the local area moving away for out-of-town retail options. The Homogeneous High Street is breaking down. Points of difference have become more important appreciating independents and living/working closer to their local offer. The Council's part is to provide leadership and a plan of action for business, but they cannot solve all the problems. The Council Partnership Conference in May 2021 came away with 5 key themes for the development of the High St: 1. People wanted town centres to be a destination point 2. People wanted walkable/pedestrianised, green spaces in their High Streets. 3. People wanted a more balanced usage in town centres – including civic uses 4. The local authority needs to have a creative approach to town planning and repurposing spaces

5. Need for digital offer on the High St – embracing mobile revolution

Headline Topic	Why can you not organise the Lido being reopened again?
Response	Cllr Chard: when looked at redeveloping in 2018, the current administration gave an open brief with different views to be considered. The key points to be achieved were that pedestrians were to be given priority and a bigger open space than currently was to be provided. Design competition by RIBA – 5 designs came through; one included a pool but was not the most popular design in the consultation. The Hopkins design gained most support offering flexible community space for varied use eg markets/arts/festivals. The lido idea is very popular, but people preferred a more flexible use of the space.

	Cllr Neden-Watts: Process for Planning and overcoming land ownership issues dictate the timescales.
	Cllr Chard: current timeline: planning application Dec 2021, if successful procure constructor towards Summer 2022,
Response	work would start later in 2022 – depends on ownership negotiations. Early 2024 for completion.
