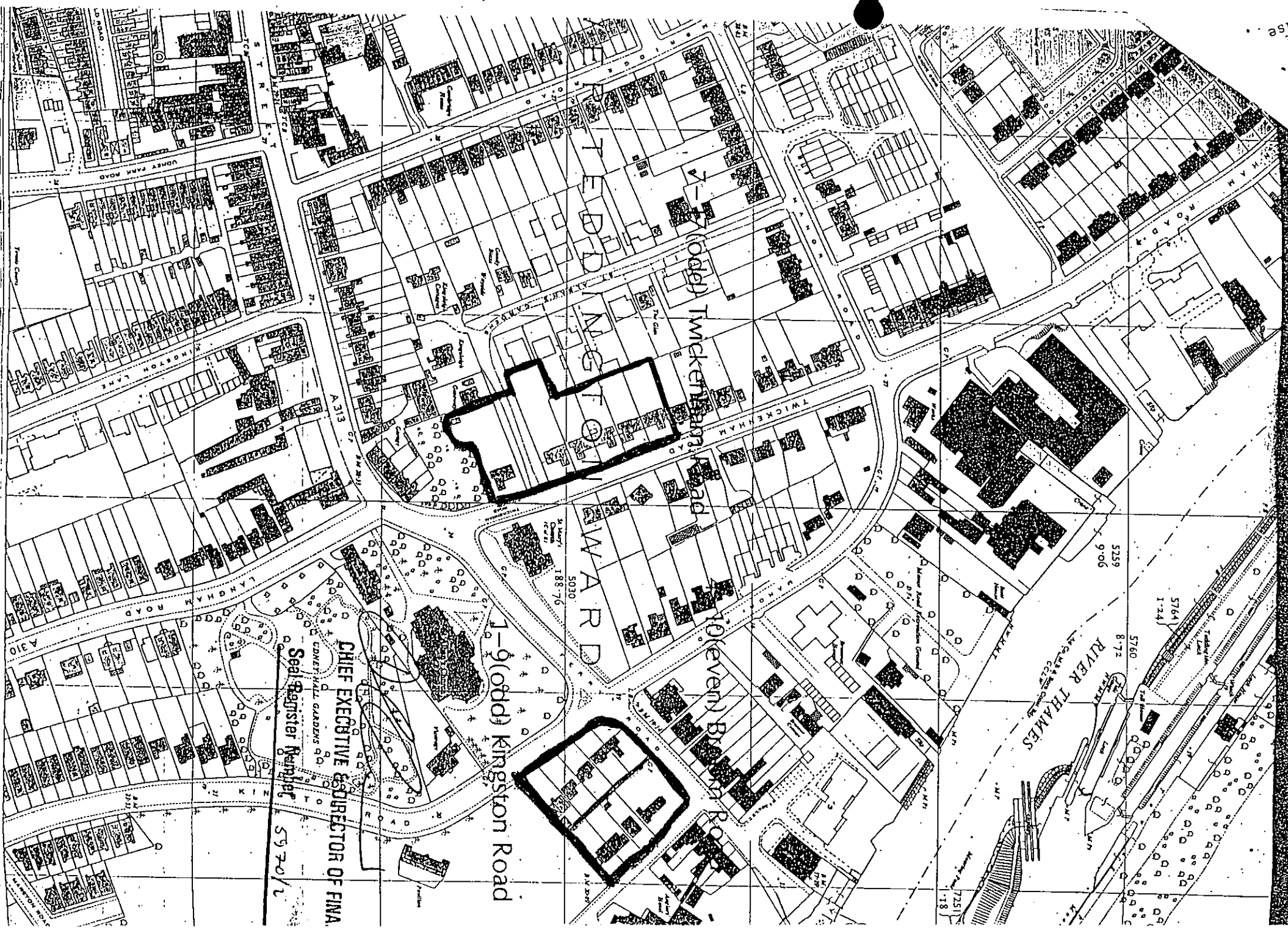

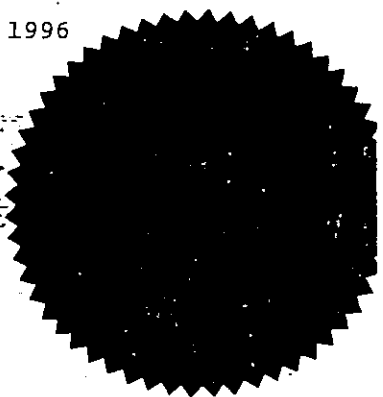

WHEREAS the Council of the London Borough of Richmond upon Thames (hereinafter referred to as "the Council") being the local planning authority for its area is satisfied that it would constitute a threat to the amenities of their area if development of the descriptions set out in Schedule B hereto should be carried out on the land shown edged with thick black lines on the plan annexed hereto and comprising the properties in Teddington in the London Borough of Richmond upon Thames described in Schedule A hereto the said land being within the Teddington Lock Conservation Area and Teddington High Street Conservation Area in the London Borough of Richmond upon Thames, unless permission therefor is granted by the Council on an application made in that behalf

NOW THEREFORE the Council in pursuance of the powers conferred upon it by Article 4(2) of the Town and Country Planning (General Permitted Development) Order 1995 ("the 1995 Order") HEREBY DIRECT that the permission granted by Article 3 and Classes A C D F and H of Part 1 Classes A and C of Part 2 and Class B of Part 31 of Schedule 2 to the 1995 Order and set out in Schedule B hereto shall not apply to development insofar as such development would front onto a highway or open space and SUBJECT to the Provisos specified in the said Schedule B on the said land and that this Direction may be cited as the "London Borough of Richmond upon Thames (Teddington Lock and Teddington High Street Conservation Areas) Article 4(2) Direction 1996"



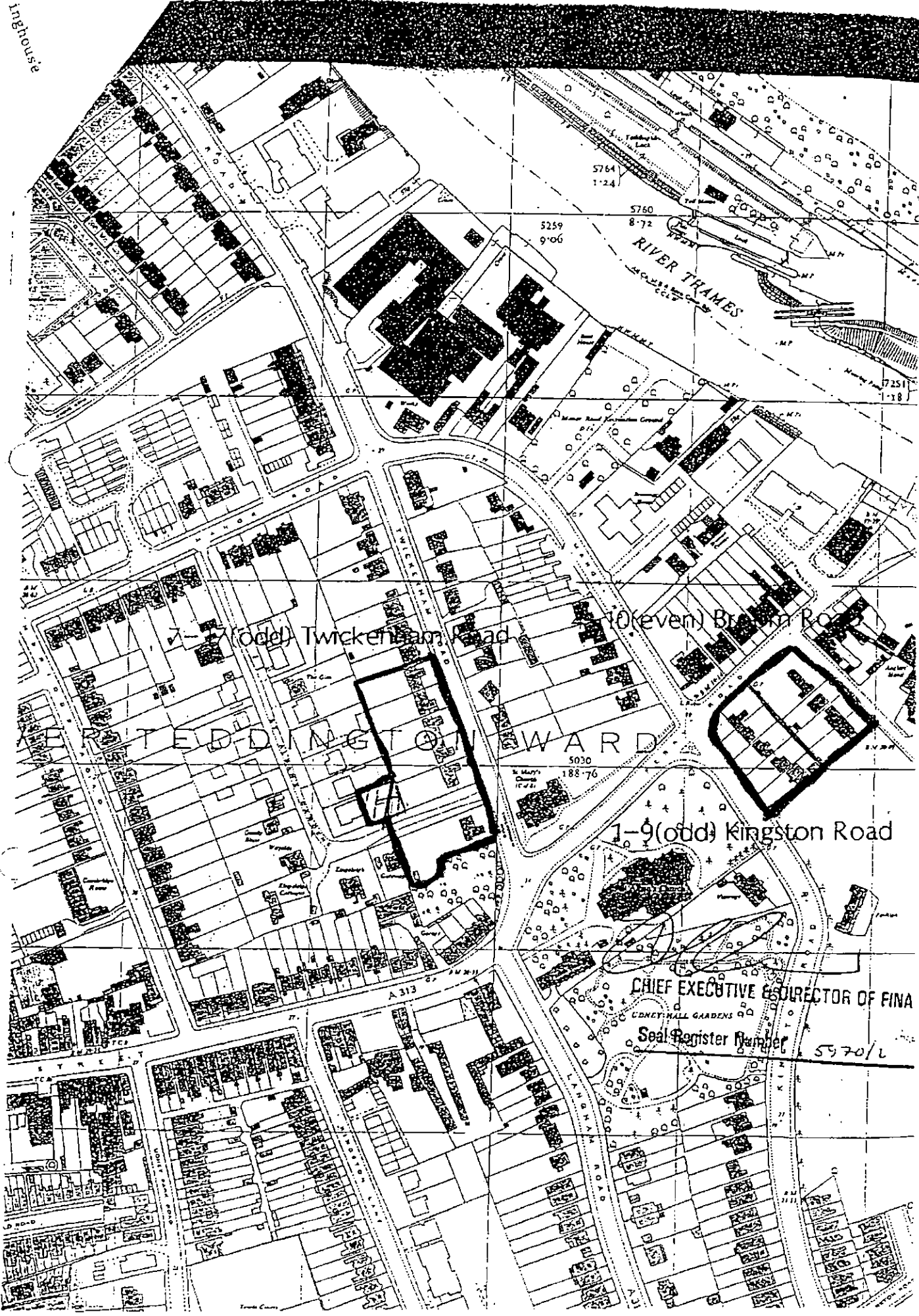
