Christmas Day - See club rules

Good Friday - 12:00 to 22:30

New Year's Eve - Alcohol may be sold from the end of the hours for the sale of alcohol on New Year's Eve until the start of the hours for the sale of alcohol on New Year's Day.

" The supply of alcohol by or on behalf of a club to, or to the order of, a member of the club.

" The sale by retail of alcohol by or on behalf of a club to a guest of a member of the club for consumption on the premises where the sale takes place.

## Annex 2 - Conditions consistent with the Club operating Schedule

This licence is granted on the condition that the restrictions contained within the enactments specified under Licensing Act 2003 Schedule 8, Para 6(8) are adhered to.

Alcohol shall not be sold, supplied, consumed in or taken from the premises except during permitted hours.  
In this condition, permitted hours means:

- a. On weekdays, other than Christmas Day, Good Friday or New Year's Eve, 11:00 to 23:00
- b. On Sundays, other than Christmas Day or New Year's Eve, 12:00 to 22:30
- c. On Good Friday, 12:00 to 22:30
- d. On New Year's Eve, except on a Sunday, 11:00 to 23:00
- e. On New Year's Eve on a Sunday, 12:00 to 22:30
- f. On New Year's Eve from the end of permitted hours to the start of permitted hours on the following day, which would be 11:00 if New Year's Day fell on a weekday or 12:00 if a Sunday.
- g. On Christmas Day, as provided by the rules of the club and notified in writing by the chairman or secretary of the club to the licensing authority. The said hours shall:
  - i. not exceed six and a half hours;
  - ii. not begin earlier than 12:00;
  - iii. not end later than 22:30;
  - iv. provide for a break of at least 2 hours, including 15:00 to 17:00;
  - v. not extend for more than three and a half hours after 17:00

The above restrictions do not prohibit:

- a) during the first twenty minutes after the above hours, the consumption of the alcohol on the premises;
- b) during the first twenty minutes after the above hours, the taking of alcohol from the premises, unless the alcohol is supplied or taken in an open vessel;
- c) during the first thirty minutes after the above hours, the consumption of the alcohol on the premises by persons taking meals there if the alcohol was supplied as ancillary to the meals;
- d) the supply to, or consumption by, any person of alcohol in any premises where they are residing.
